## GENERAL REQUIREMENTS AND RULES:

- 1. "The Range" is open from dawn to dusk, unless otherwise posted or stated by the Town. No practice is allowed at any other time.
- 2. Any archery practice requires a permit for "The Range" issued by the Town of Secaucus. Permits can be obtained by residents at the Town Clerk's Office, 1203 Paterson Plank Road, during normal business hours.
- 3. Please have your permit available while at "The Range." Permits must be presented to the Secaucus Police, Park Patrol or other Town representatives upon request. Any person shooting on "The Range" without a valid Town of Secaucus permit or as a guest with a Town of Secaucus permittee is subject to removal and penalties.
- 4. Children must be at least seven (7) years old to shoot at "The Range," unless they are taking a lesson or received prior approval from the Town.
- 5. Direct, visual supervision by an adult twenty-one (21) years of age or older is required for everyone under the age of eighteen (18) years old.
- 6. The Town does not provide equipment. Equipment must meet current safety standards. All persons <u>MUST</u> wear closed toe shoes on "The Range."
- 7. Field points, long bows, recurve bows and compound bows are permitted. The following are not permitted to be used: broadheads, razor tipped arrow points, cross bows, mechanical tipped arrows, blunt point tips, firearms, slingshots, BB guns, spears, knives or air guns.
- 8. Use of existing targets is permitted as well as freestanding or alternate targets in designated spaces. No glass bottles, hay bales or live targets shall be permitted.
- 9. Obey all posted signs.
- 10. Be aware of all marked lines and zones for player safety. Do not cross the safety line.
- 11. Please dispose of all litter and garbage properly in marked receptacles.
- 12. No alcoholic beverages permitted.
- 13. "The Range" is in an area for recreation and wildlife habitats. Please be aware of your surroundings and of others in the area. Hunting, trapping and fishing are prohibited.
- 14. Please act and practice responsibly. All rules and regulations of the Town of Secaucus shall be followed at all times.
- 15. "The Range" is unsupervised. Use of "The Range" is at your own risk. The Town is not responsible for any injury, accidents, damage or loss to persons or property.
