ORDINANCE NO. 2017-27

AN ORDINANCE AMENDING CHAPTER 12 OF THE CODE OF THE TOWN OF SECAUCUS ENTITLED "FIRE DEPARTMENT" UPDATING MEMBERSHIP REQUIREMENTS

WHEREAS, the Mayor and Council recognize that the safety of all residents and the protection of buildings and structures is of utmost concern and that the ability to provide emergency fire services is critical to the protection of the public; and

WHEREAS, the Town of Secaucus' Volunteer Fire Department serves the fire and emergency response needs of the municipality and is governed by T.O. 12-1 et seq.; and

WHEREAS, updates are being proposed to membership requirements for the Fire Department upon review of the current qualifications.

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Town of Secaucus, County of Hudson, State of New Jersey, as follows:

- 1. Chapter 12 of Code of the Town of Secaucus, "§12-2. Membership of companies." be, and is hereby amended and supplemented to read as follows: (deletions are indicated by erossouts; additions are indicated in **bold**):
- B. Qualifications of firefighters. Each member of the Secaucus Volunteer Fire Department shall meet, and continue to meet, the following qualifications:
- (b) Be a citizen of the United States or have current legal status within the United States and be a resident of the Town of Secaucus.
- 5. Have a valid New Jersey driver's license. A motor vehicle record check will be conducted for all applicants and shall be satisfactory to the Department in accordance with Town policy. Applicants and members shall provide any necessary information and complete any necessary documents for a motor vehicle check to be conducted.
- D. Each engine company and hose company shall consist of the following maintain a minimum number of qualified members:
 - 1. Engine Company No. 1: No less than twelve (12) qualified members-nor more than twenty (20) qualified members.
 - 2. Engine Company No. 3: No less than twelve (12) qualified members nor more than twenty (20) qualified members.
 - 3. Hose Company No. 1 Engine Company No. 2/Fire Rescue No. 1: No less than seventeen (17) qualified members nor more than twenty-five (25) qualified members.

- 4. Hose Company Tower No. 2: No less than twelve (12) qualified members nor more than twenty (20) qualified members.
- 5. Engine Company No. 4/Ladder 1: No less than seventeen (17) qualified members nor more than twenty-five (25) qualified members.
- E. The Secaucus Fire Department shall be permitted to maintain a junior firefighter program. Each member of the Secaucus Junior Firefighter Program shall meet and abide by the following:
 - (2) Be a citizen of the United States or have current legal status within the United States and be a resident of the Town of Secaucus.
- 2. There are no other changes to this Chapter of the Code of the Town of Secaucus.
- 3. All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.
- 4. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to that section, subdivision, clause or provision so adjudged and the remainder of this Ordinance shall be deemed to be valid and effective.
- This Ordinance shall take effect immediately upon passage and publication in accordance with law.

IT IS FURTHER ORDAINED that the remainder of this Chapter 12 of the Code of the Town of Secaucus shall remain in full force and effect.

ORDINANCE NO. 2018-1

AN ORDINANCE AMENDING SECTION 127-58B OF THE CODE OF THE TOWN OF SECAUCUS ENTITLED "DESIGNATION OF LOCATIONS AT OR NEAR PRIVATE RESIDENCES"

SECTION 1

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Secaucus that Section 127-58B - "Designation of Locations at or Near Private Residences" shall be amended by deleting the following locations:

NAME OF STREET	SIDE	LOCATION
Franklin Street	South	On the south side of Franklin Street, beginning at a point 106 feet east of the southeast corner of Garry Terrace and Franklin Street continuing east for a distance of 22 feet in front of 99 Franklin Street

SECTION 2

SEVERABILITY

BE IT FURTHER ORDAINED, that the provisions of this ordinance are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, or unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words, or parts of the regulation or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this ordinance would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and if such persons or circumstances, to which the ordinance or part thereof is held inapplicable, had been specifically exempted therefrom.

SECTION 3

REPEALER

BE IT FURTHER ORDAINED, that all other ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed, to the extent of such inconsistency.

SECTION 4

EFFECTIVE DATE

BE IT FURTHER ORDAINED, that this ordinance shall take effect upon passage and publication as provided by law.

ORDINANCE NO. 2018-2

AN ORDINANCE GRANTING A PERMANENT UTILITY EASEMENT TO NEW JERSEY DEPARTMENT OF TRANSPORTATION ON BLOCK 132, LOT 3

WHEREAS, the Town of Secaucus is the owner of certain property located within the Town of Secaucus identified as Block 132, Lot 3 on Tax Maps and Parcel UE112A consisting of approximately 100 square feet as depicted on the attached map prepared for the New Jersey Department of Transportation; and

WHEREAS, at the request of the New Jersey Department of Transportation, the Town of Secaucus wishes to grant to the New Jersey Department of Transportation (NJDOT) a permanent easement on the above property for the construction, maintenance and repair of utility pole guy wires and guy anchor above and below ground appurtenances; and

WHEREAS, acceptance of the conveyance of said real property requires the approval by Ordinance of the Town Council pursuant to N.J.S.A. 40A:12-5; and

WHEREAS, the Town Council has determined that it is in the best interest of the public to provide said utility easement.

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Town of Secaucus, County of Hudson, State of New Jersey:

- 1. The Town of Secaucus hereby accepts the dedication of a permanent utility easement on Block 132, Lot 3 for the construction, maintenance and repair of utility pole guy wires and guy anchor above and below ground appurtenances.
- 2. The Mayor, Town Administrator and the Town's Counsel are hereby authorized to execute the easement document(s) necessary for the construction, maintenance and repair of utility pole guy wires and guy anchor above and below ground appurtenances on the property more particularly described as Block 132, Lot 3 on Secaucus Tax Maps and as Parcel UE112A, consisting of approximately 100 square feet, as depicted on the attached map prepared for the New Jersey Department of Transportation.
- 3. All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.
- 4. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to that section, subdivision, clause or provision so adjudged and the remainder of this Ordinance shall be deemed to be valid and effective.
- 5. This Ordinance shall take effect immediately upon passage and publication in accordance with law.

RESOLUTION NO. ______ - 2018 RESOLUTION AUTHORIZING INTEREST RATE/GRACE PERIOD/YEAR-END PENALTY

WHEREAS, N.J.S.A. 54:4-67 et seq., permits the Mayor and Council to fix the rate of interest to be charged for the nonpayment of taxes, assessments, or other municipal charges.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Town of Secaucus that the rate of interest on unpaid taxes shall be eight percent (8%) per annum for the first One Thousand Five Hundred Dollars (\$1,500.00) of delinquency and eighteen percent (18%) per annum on any amount in excess of One Thousand Five Hundred Dollars (\$,1500.00) to be calculated from the date the tax was payable until the date of actual payment, provided that no interest shall be charged if payment of any installment is made on or before the tenth (10th) calendar day following the date upon which the same became payable; and,

BE IT FURTHER RESOLVED, that in addition to the interest provided above, on all delinquencies in excess of Ten Thousand Dollars (\$10,000.00) and which are not paid prior to the end of the year, the Tax Collector shall also collect a penalty of six percent (6%) of the amount of the delinquency in excess of Ten Thousand Dollars (\$10,000.00).

BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded to the Town Tax Collector.
