ORDINANCE NO. 2019-37

AN ORDINANCE AMENDING SECTION 127-58B OF THE CODE OF THE TOWN OF SECAUCUS ENTITLED "DESIGNATION OF LOCATIONS AT OR NEAR PRIVATE RESIDENCES"

#### SECTION 1

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Secaucus that Section 127-58B - "Designation of Locations at or Near Private Residences" shall be amended by <u>adding</u> the following location:

NAME OF STREET	SIDE	LOCATION
Grace Avenue	North	On the north side of Grace Avenue beginning at a point 180 feet east of the northeast corner of Schopmann Drive and Grace Avenue continuing east for a distance of 18 feet in front of 248 Grace Avenue

That the parking space designated for 248 Grace Avenue adopted by Ordinance is to be personalized for Placard No. P2162848.

If the license plate for the person utilizing the parking Space at the above listed address changes, then the parking space designation shall be changed to the new plate with proof from the resident that it is for the same person that the person is still entitled to handicapped parking.

### SECTION 2

#### SEVERABILITY

Dear Capt. Miller,

As you know, PierCon's activities to re-design your current police and fire two-way radio channels for simulcast operation, and to add a new police/fire repeater site in the southern area of town, requires that the new transmitter site be approved and licensed by the Federal Communications Commission (FCC).

Our work to-date indicates that the FCC will approve the operation of your fire and one of your police channels at your proposed new southern transmitter site at the output power we believe is necessary. Your other police frequency, however, may be too close to other agencies who are also licensed to operate on that frequency (Randolph Board of Education, NJ; Clark, NJ; Hempstead, NY; and Eastchester Fire, NY). If we move forward, one of your two UHF channels will have a higher licensed power than the other, a condition we believe is prudent to avoid if possible.

In order for us to license both of your UHF frequencies at the same output power we propose following the FCC's "Letter of Concurrence" process (47 C.F.R. §90.187) which basically asks your co-licensee agencies to approve your license application with the understanding that you will not subject them to harmful interference. We believe that you will not produce harmful interference to these agencies, if for no other reason you already share this frequency with them.

This quote is to provide Secaucus with assistance to prepare your Letter of Concurrence requests, and to produce for you an attachment to graphically show your signal today and your signal after your proposed south transmitter site.

The possible need for this process was identified in our original proposal ("Secaucus' Needs and Goals), bullet point two:

Prepare for you the frequency coordination request and FCC license request needed for the operation of the new system. You will be responsible for the minimal fee charged by the frequency coordination. <u>Should coordination require that you</u> prepare detailed propagation plans and/or customized antenna designs, or if your licensing requires a Letter of Concurrence process, these will be guoted as extras.

I recommend that you use the Letter of Concurrence process to obtain equal licensed transmitter power for your two UHF police frequencies. In this fashion your new system will provide equal coverage to users of either channel.


