AN ORDINANCE AMENDING CHAPTER 12 OF THE CODE OF THE TOWN OF SECAUCUS ENTITLED "FIRE DEPARTMENT" TO UPDATE ELECTION TIMING

WHEREAS, the Mayor and Council recognize that the safety of all residents and the protection of buildings and structures is of utmost concern and that the ability to provide emergency fire services is critical to the protection of the public; and

WHEREAS, the Town of Secaucus' Volunteer Fire Department serves the fire and emergency response needs of the municipality and is governed by T.O. 12-1 et seq.; and

WHEREAS, updates are recommended by the Fire Chiefs and the Secaucus Volunteer Fire Department Mutual Association as to election timing for the Fire Department to allow for a timely process and adequate transition period.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Secaucus, County of Hudson, State of New Jersey, as follows:

 Chapter 12 of Code of the Town of Secaucus, "§12-4. Terms of office; election of Battalion Chief; office of Fire Chief and Deputy Chief." be, and is hereby amended and supplemented to read as follows: (deletions are indicted by crossouts; additions are indicated in bold):

- A.

 The term of Fire Chief, Deputy Chief, and Battalion Chief shall each be for two (2) years, and shall commence as of January 1st of each year.
- B.

 1.
 The Battalion Chief, who, in order to qualify must have served as Captain of his respective company for at least two years, shall be elected for a two (2) year term by ballot of the members of the Fire Department. Such Battalion Chief shall be elected from that company where it is designated by order of rotation to have such Battalion Chief elected. The order of rotation is as follows: first from Engine Company No. 1, then from Engine Company No. 3, then Engine Company No. 2/Rescue No. 1, then Hose Company Tower No. 2, and then Truck Company No. 1/Engine Company No. 4 (no preference is implied by this order of rotation).
 - Nominations for Battalion Chief shall be made in October of the appropriate year, with a deadline of October 31. The election shall be conducted in December November, prior to December 22nd November 30 between the hours of 7:00 p.m. and 9:00 p.m. at the firehouse from where the new Battalion Chief is to be elected, and one member of each company selected by such company shall act as an inspector of such election; one inspector shall be designated the head of the election committee. Said inspectors shall supervise the election, by secret ballot, and shall thereupon proceed to take the votes of the Department; the person receiving the greatest number of votes for Battalion Chief shall be declared elected, subject to the approval of the Mayor and Council, and the head of the committee shall report the results to the Mayor and Council at the first meeting thereafter. Such person shall be confirmed by the Mayor and Council, or the Mayor and Council may choose, for good cause, not to confirm such person whereupon a new election shall be held. The filing of absentee ballots from all members of the Fire Department who are unable to vote in person at such election shall be permitted, provided that such absentee ballots are received prior to such election; the Fire Chief may establish such rules and regulations as may be necessary to effectuate such absentee ballot voting procedure.
 - The election date shall be selected by the Mayor and Council Secaucus Volunteer Fire Department Mutual Association in consultation with the three (3) chiefs, and who the Secaucus Volunteer Fire Department Mutual Association shall provide written notice to the senior officer for each firehouse at least fourteen (14) days prior to the election. Written notice of the election shall be prominently posted at each firehouse at least ten (10) days prior to the election. Nomination and election dates may be changed for cause by the Fire Chief upon approval of the Mayor and Council.
- C.

 At the expiration of the term of the Fire Chief, the Deputy Chief shall become the Chief. After the expiration of the term of the Deputy Chief, the Battalion Chief shall become the Deputy Chief.

- 2. There are no other changes to this Chapter of the Code of the Town of Secaucus.
- 3. All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.
- 4. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to that section, subdivision, clause or provision so adjudged and the remainder of this Ordinance shall be deemed to be valid and effective.
- 5. This Ordinance shall take effect immediately upon passage and publication in accordance with law.

AN ORDINANCE AMENDING CHAPTER 104 OF THE CODE OF THE TOWN OF SECAUCUS ENTITLED "PROPERTY MAINTENANCE" TO SPECIFY MAINTENANCE RESPONSIBILITIES PERTAINING TO SOLAR PANELS

WHEREAS, the Town wants to ensure that the conditions and maintenance of all property, buildings and structures are safe, sanitary and fit for occupation and use by regulating standards and conditions for the protection of residents, occupants, visitors, pedestrians and the general community; and

WHEREAS, the Town has previously adopted an Ordinance, Chapter 104, setting forth interior and exterior property maintenance standards for properties within its bounds; and

WHEREAS, the Mayor and Council support safe residential solar panel installation and maintenance as solar energy is beneficial to reducing the carbon footprint and removes reliance on non-renewable energy sources; and

WHEREAS, changes to the Town's Ordinance are needed to supplement the responsibilities of property owners to maintain solar panels in a safe, secure manner,

particularly in adverse weather conditions, in the interest of health and safety of property and persons as snow can accumulate on solar panels, particularly those on rooftop locations, resulting in snow slides or avalanches of snow onto driveways, walkways and property below, creating a serious safety hazard.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Secaucus, County of Hudson, State of New Jersey, as follows:

- 1. Chapter 104 entitled "Property Maintenance" of the Code of the Town of Secaucus, Article IV Exterior Maintenances Standards, §104-11(B) shall be supplemented and amended as follows (additions are indicated in bold):

It shall be the duty of the owner or operator to keep the premises free of hazards and unsightly or unsanitary conditions which include, but are not limited to, the following:

Snow and ice shall not be allowed to accumulate on or be discharged off a solar panel so as to cause a hazardous condition. Solar panel snow guards or other hazard mitigation measure shall be utilized to eliminate excessive accumulations of snow and ice on solar panels within ten (10) feet of a roof edge or open side of a walking surface and such edge or open side is located more than thirty (30) inches above the floor, roof or grade below. All installation and placement of solar panels and snow guards shall be in accordance with all zoning regulations applicable to the property.
