ORDINANCE FOR PUBLIC HEARING

The following ordinance was read for public hearing: No. 2023-5

AN ORDINANCE AMENDING CHAPTER 127 OF THE CODE OF THE
TOWN OF SECAUCUS ENTITLED "VEHICLES AND TRAFFIC"
TO UPDATE PARKING METER LOCATIONS AND LIMITS

WHEREAS, the Town has previously adopted an Ordinance specifying locations, fees and time limits for all parking meters in the Town; and

WHEREAS, the Mayor and Council have determined that changes to Article XIII of Chapter 127 of the Code of the Town of Secaucus are needed to update time limits, locations and fees for metered spaces throughout the Town.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Secaucus, County of Hudson, State of New Jersey, as follows:

1. Chapter 127 entitled "Vehicles and Traffic," Article XIII entitled "Parking Meters," §127-49 et seq. of the Code of the Town of Secaucus be, and is hereby amended and supplemented to read as follows (deletions are indicated by ~~cross-outs~~; additions are indicated in bold):

§ 127-55. Parking meter zones and time limits.

5. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
IT IS FURTHER ORDAINED, that the remainder of this Chapter of the Code of the Town of Secaucus shall remain in full force and effect.

AN ORDINANCE AMENDING CHAPTER 127 OF THE CODE OF THE TOWN OF SECAUCUS ENTITLED "VEHICLES AND TRAFFIC" TO INCLUDE MOBILE BASED PARKING APPLICATION PAYMENT OPTION

WHEREAS, the Town of Secaucus has established an Ordinance authorizing the designation of certain Town areas as parking meter zones, and requiring persons and vehicles parking within the zones to pay a fee for a period of parking; and

WHEREAS, the Town has previously adopted an Ordinance contained in Chapter 127 entitled "Vehicles and Traffic" to specifically address parking meter zones and the operation of such; and

WHEREAS, the Mayor and Council have determined that changes to the Ordinance are warranted to update §§127-49 to -54 to address changes in meter and paid parking technology, and reflect the Town's anticipated launch of a mobile payment application option.

NOW THEREFORE BE IT ORDAINED by the Mayor and Council for the Town of Secaucus, County of Hudson, State of New Jersey, as follows:

1. Chapter 127, §127-49 to -54 of the Code of the Town of Secaucus be and is hereby replaced and amended to read as follows: (deletions are indicated by ~~crossouts~~ and additions are indicated in bold):

§ 127-49 Definitions.

As used in this article, the hereinafter defined words and phrases shall have the following meanings:

...

PAID PARKING ZONE

All areas designated by ordinance where a vehicle may be temporarily parked and allowed to remain for the time indicated on the parking meter, ~~or~~ on the parking pay station or on the mobile based parking application pursuant to such an ordinance.

...

TIME LIMIT

A period of time designated by ordinance where a vehicle may temporarily park for such period after depositing a coin or fee in a parking meter, in ~~or~~ a parking pay station or on the mobile based parking application in a paid parking ~~meter~~ zone.

...

§ 127-51 Installation of meters and parking pay stations.

Parking meters, ~~or~~ parking pay stations and/or mobile based parking application signage shall be installed in the paid parking zones as established and provided for by ordinance. ...

§ 127-52 Use of meters, ~~and~~ parking pay stations and mobile based parking application.

Any person desiring to park any vehicle within a paid parking zone shall deposit the proper coins or fee for the time desired in accordance with this article. The Town may ~~equip a parking meter or parking pay station to~~ accept the parking fee via cash, coins, credit card, debit card, or bank debit card or through an authorized third-party vendor. A service fee may be assessed by a third-party vendor on the user.

...

§ 127-54 Deposit of revenues in Town treasury.

All revenues created by the parking meters, ~~or~~ parking pay stations or via the mobile based parking application within the Town of Secaucus shall be deposited into the general Town treasury for use to defray the expense of operating such meters, ~~or~~ stations and applications.

- 2. The above reflects the full revision to Chapter 127, Article XIII.
- 3. All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.
